WEDNESDAY, 5 NOVEMBER 2025

The Assembly met pursuant to the adjournment.

:

1. The Speaker took the Chair and read the Prayer and Affirmation.

2. **FIRST ORDER READ:**

Committee Stage – Appropriation Amendment Bill [B. 11 – 2025].

The Minister of Finance moved, seconded by Hon. Mukapuli: That the Assembly goes now in Committee.

Agreed to.

ASSEMBLY IN COMMITTEE:

Clause 1 put and agreed to.

Clause 2 put and agreed to.

Schedule put and agreed to.

Title put and agreed to.

ASSEMBLY RESUMED:

Bill reported without amendment.

The Minister of Finance moved, seconded by the Minister of Works and Transport: That the Bill be read a Third Time.

Agreed to.

Appropriation Amendment Bill [B. 11 – 2025] read a Third Time with 56 voting Members present.

3. **SECOND ORDER READ:**

Resumption of Debate on Second Reading – *Mental Health Bill* [B. 8 – 2025].

Question before the Assembly on Thursday, 30 October 2025, as moved by the Minister of Health and Social Services (page 160).

Question put: That the Bill be read a Second Time.

Agreed to.

Mental Health Bill [B. 8 – 2025] read a Second Time with 49 voting Members present.

4. **THIRD ORDER READ:**

Resumption of Debate on Second Reading – *Public Enterprises Governance Amendment Bill* [B. 10 – 2025].

Question before the Assembly on Tuesday, 4 November 2025, as moved by the Right Hon. Prime Minister (page 151): That the Bill be read a Second Time.

5. **FOURTH ORDER READ:**

Resumption of Debate on Second Reading – *Land Bill* [B. 2 – 2025].

Question before the Assembly on Wednesday, 8 October 2025, as moved by the Minister of Agriculture, Fisheries, Water and Land Reform (page 152): That the Bill be read a Second Time.
