THURSDAY, 5 FEBRUARY 2026

The Assembly met pursuant to the adjournment.

1. The Speaker took the Chair and read the Prayer and Affirmation.
2. **Announcement by the Speaker in terms of Rule 117(b) of the Standing Rules and Orders:**

As was reported yesterday, the Speaker announced that due to the vacant position of the Deputy Chairperson of the Whole House Committee as a result of the resignation of Hon. Herunga, that the Assembly shall now proceed to elect a Deputy Chairperson of the Whole House Committee in terms of Rule 32 read with Rule 28 of the Standing Rules, Orders and Internal Arrangements.

The Speaker called for nominations.

3. **Nominations of the Deputy Chairperson of the Whole House Committee:**

Hon. Ester Haikola, seconded by Hon. McHenry Venaani, nominated Hon. Prof. Dr. Job Amupanda to be the Deputy Chairperson of the Whole House Committee, and Hon. Prof. Dr. Amupanda accepted his nomination.

Further, Hon. Uahekua Herunga, seconded by Hon. Clemencia Coetzee, nominated Hon. Alpheus !Naruseb to be the Deputy Chairperson of the Whole House Committee, and Hon. !Naruseb accepted his nomination.

4. **Hon. Prof. Dr. Amupanda rose to address the Assembly:**

That he is withdrawing from contesting the vacant position of the Deputy Chairperson of the Whole House Committee, in support of Hon. !Naruseb.

Hon. Prof. Dr. Amupanda's withdrawal accepted.

The Speaker announced Hon. !Naruseb as a duly elected Deputy Chairperson of the Whole House Committee.
