EXECUTIVE SUMMARY OF BID EVALUATION REPORT

Project Title: Scope of Contract: SUPPLY AND DELIVERY OF EIGHT (8) STANDARD LAPTOPS FOR THE OFFICE OF THE CHAIRPERSON

Reference number of procurement: G/RFQ/ 11-01/2026/2027

1. **Scope of Contract:** Supply and delivery of eight (8) standard laptops for the office of the chairperson
2. **Procurement method used:** Request for Sealed Quotation
3. **Date of Invitation of Bids:** 01 April 2026
4. **Closing date for submission of bids:** 17 April 2026
5. **Date and place of opening of bids:** 17 April 2026, Erf 14 Love Street, National Council - Parliament
6. **Number of bids received by closing date:** Eighty-Six (86)
7. **Responsiveness of bids:** Two (2)

A total of eighty-six (86) bids were received in response to the above-mentioned procurement. Given the substantial number of bids submitted, and in accordance with Section 52(12) of the Public Procurement Act No. 15 of 2015 which provides that *"Where a substantial number of bids are tendered and it is not practical to evaluate all the bids, the Board or the public entity may select a sufficient number of lowest priced bids to evaluate after completing the preliminary examination"*

Procurement Committee has, following the completion of the preliminary examination, selected the twenty-six (26) lowest priced bids for re-evaluation which represents 30% of the total number of bids.
