Kindly take note that **Polar Power Trading Cc** has been selected for the provision of plumbing services to the National Council under a service level agreement for a period of twelve (12) months.

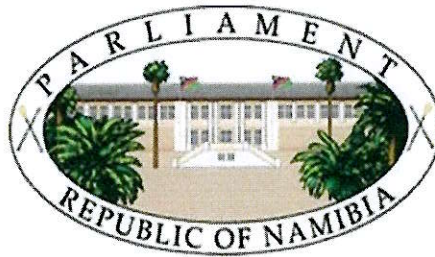

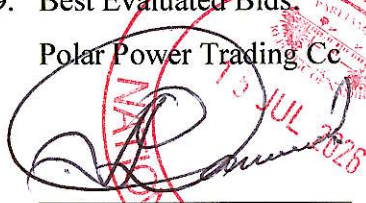
