1. Purchaser

The Public Entity inviting the Informal Quotation is the Purchaser for the purpose of entering into contract with the successful bidder.

2. Supplier

The Bidder having submitted the lowest price and whose offer is substantially responsive to the requirements specified shall be selected for award of contract and referred to as the Supplier.

3. Rights of the Public Entity

The Purchaser shall have the right to

- (a) Ask for clarifications at time of evaluating quotations,
- (b) Split the contract on an item basis or
- (c) Reject all quotations.

A Purchaser shall not be bound to accept the lowest or any quotation.

4. Eligibility Criteria

- (a) Have an original valid good standing of **Company Registration Certificate** specifying shareholders or copy certified by a Commissioner of Oath appointed in terms of the Justice of the Peace and Commissioner of Oaths Act, 1963 (Act No 16 of 1963). Certificate must be valid as at the date of bid submission;
- (b) Have an original **Good Standing Tax Certificate** or copy certified by a Commissioner of Oath appointed in terms of the Justice of the Peace and Commissioner of Oaths Act, 1963 (Act No 16 of 1963). Certificate must be valid as at the date of bid submission;
- (c) Have an original valid **Good Standing Social Security Certificate** or copy certified by a Commission of Oath appointed in terms of the Justice of the Peace and Commissioner of Oaths Act, 1963 (Act No 16 of 1963); A printout of valid electronic or online document issued in terms of the Electronic Transaction Act, 2019 (Act No 4 of 2019), subject to the authentication or validation of such printout by a public entity during the bid evaluation process, in accordance with authentication or validation guidelines of the issuing authority. - (d) Have an original valid **Employment Equity Commissioner or valid certified Affirmative Action Compliance Certificate**, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998. - (e) Submit a duly completed signed and stamped Written undertaking as contemplated in section 138(2) of the Labour Act, 2007;

- (g) The bidders must complete **SCHEDULE 2: Cost Structure for Value Added Calculation per product and ensure that it is certified by a certified accountant. Proof of a Power of Attorney must be provided.**
- (h) The bidder **must be a Namibian citizen** or, where the bidder is a juristic person, an entity incorporated in Namibia that is at least 51% beneficially owned by Namibian citizens.
- (i) **Bidders MUST attach declarations as indicated in the Margin of Preference on company letterhead stamped and signed by an authorised person or company representative in order to qualify for the margin of preference. A bidder that does not qualify under any of the categories listed in ITB6, is not eligible to participate in the procurement reserved for the identified categories and will therefore be disqualified.**
- (j) **A bidder who is unable to provide satisfactory evidence demonstrating that its goods meet the local content threshold of 40%, as prescribed in the Code of Good Practice will be disqualified.**

5. Bid Securing Declaration

Bidders are required to subscribe to a Bid Securing Declaration for this procurement process. The bidder shall furnish as part of its quotation, a Bid Securing Declaration as per the format contained in Schedule 1 of this document.

6. Margin of Preference

The applicable margins of preference applicable for Exclusive Preference to Local Suppliers and their application methodology are as follows:

7. Prices

8. The Contract

The letter of Acceptance/Purchaser Order Form as the case may be together with this Informal Quotation form shall constitute the contract between the Public Entity and the Supplier.

9. Purchase order

A supplier to whom a purchase order is issued must confirm the purchase order within three days of receipt of the purchase order and;

- (c) the purchase order shall be valid for (ninety) 90 days only and will be cancelled thereafter.

10. General Conditions of Contract

11. Warranty
